Important Circular

Sub: - Special provision for filling examination form for Summer 2018 Examination.

The last date for submitting examination form for Summer 2018 examination with penalty of Rs.1500/- concluded on 21/02/2018 for all the students. However there are many requests from students and institutes for opening the online examination form link.

In the interest of student community, a special provision is made to fill examination form as per schedule below;

27/03/2018	RBTE confirmation of exam forms already confirmed by Institute on 26/03/2018 with requisite exam fees & penalty and undertaking submitted by candidates & undertaking by institute.	From 11.00 a.m. 5.30 p.m.

The filling of examination form under special provision is permitted subject to following conditions.

1. The penalty for each examination form is Rs.4000.-
2. The student has to submit an undertaking as per **Annexure-I** which has to be endorsed by the parent / guardian of the student.
3. Institute shall check that the paper code for which the candidate is appearing for exam is available in Summer-2018 Time table.
4. The institute has to submit an undertaking in the form of self-declaration on the institute letterhead to the effect that they have complied with all conditions of MSBTE and indicate the list of students for whom examination forms are submitted in the special provision.
5. There will be no further provisions for filling examination form for the Summer 2018 examination after this special provision.
6. Computerized e-mark sheets of non-theory subject heads like ESE/PA/TW/PR/OR/SW for these candidates will be made available in institute login on **02/04/2018**. Institute shall conduct the OR / PR exam, fill & confirm the e-mark sheet for all eligible candidates who have filled examination forms under special provision.

All concerned are hereby instructed to strictly adhere to the conditions of this circular.
